COLLEGE FEE RULES & REGULATIONS

1. If the fee remains unpaid by the due date, a late fee of Rs. 100/- per day for the first 30 days and Rs. 5000/- per month for the remaining period will be charged.
2. Any Cadet whose fee is not paid within one month after due date, his name is liable to be struck off the College Rolls and may be re-admitted on payment of Rs. 10000/- subject to approval of the Head of the Institution/College Council.
3. No Cadet will be allowed to appear in Board Examination or for the annual examination, unless his accounts have been settled in full by the date on which the examination begins.
4. The Cadets appearing for the Board Examination (9th, 10th, 11th & 12th) will pay the messing and boarding charges upto end of the month in which their Board Examination including practicals finishes.
5. Cadet who remains absent from the College without any information or prior approved leave for six consecutive days is liable to be struck off the College Rolls. Re-admission on fee of Rs. 10000/- is charged in case they are allowed to rejoin the College, subject to approval of the Head of the College/Council.
6. In case of withdrawal of a cadet by the parents/guardian, the Cadet will have to pay full dues for the term during which he is withdrawn. Dues once deposited are **NOT REFUNDABLE** in any case. There is no provision of partial adjustment/remission of the amount billed, even if a Cadet remains on the **COLLEGE ROLLS** for a part of the term.
7. All possible efforts are taken for the safeguard of all the Cadets during their stay in the College Campus, Games, PT, Drill and other activities. However, the College shall not be responsible for any kind of bunking/ accident/ mishap causing any physical harm or injury/ disablement to the Cadets.
8. All cases of gross discipline shall be referred to the Chairman, College Council. Decision taken by the Council shall be **FINAL** and **NON – CHALLENGABLE**.
9. In case of Passing Out OR Withdrawal from the College, the luggage must be collected within 07 Days of withdrawal otherwise the College Authorities will not be responsible for any loss after 07 Days.
10. The Parents are liable to pay their Sons/Wards Fee and Funds in Full, if the college is closed for Vacations or any National Calamity or Disaster as per Government Orders.
11. All the Dues and Fees, once deposited are **NON REFUNDABLE**, irrespective whether the boy joins the College or not and the manner in which the amount is expended, is **NOT** accounted to the parents. All College dues are chargeable for the full year, including vacation.

2. I have read all instructions, terms and conditions, rules and regulations mentioned in the prospectus/ Form and accept to abide by them all.
3. I will have no claim for any amount once paid to the College if I withdraw my son/ward for any reasons.
